- EXHIBITS MUST BE STAFFED AT ALL TIMES DURING THE HOURS THAT THE HALL IS OPEN.
- EXHIBITORS HIRING A REGULAR EXHIBITOR WILL BE ALLOWED A MAX. OF TWO (2) REPS
